

MyEasyFarm chooses the Agdatahub solutions to connect its platform with MesParcelles

For the 2023 International Agricultural Show, **MyEasyFarm**, the publisher of Precision Agriculture and Low-Carbon Agriculture solutions, announces the **interoperability of its platform with the leading plot management software "MesParcelles"** of the French Chambers of Agriculture, with the Agdatahub platform.



Easy connection and secure data exchange with AgriTrust's Connect and Consent modules

MyEasyFarm relies in particular on Agdatahub's new AgriTrust solution, which provides a secure connection to the MyEasyFarm platform and manages farmers' consents.

AgriTrust's Connect module will allow users to **enhance security and facilitate access to MyEasyFarm** and connected third-party applications, including MyParcelles.

AgriTrust's Consent module manages all **consent requests for access to data** hosted in the MyEasyFarm platform.

MyEasyFarm is certified <u>Data-Agri</u> (label for the security of agricultural data developed by FNSEA and Jeunes Agriculteurs) since 2019, which guarantees its users the protection, security and non-sharing of their data.



The implementation of AgriTrust's Consent module goes beyond the Data-Agri label and allows farmers to selectively exchange some of their data with their partners, in a secure digital environment.

Some examples: send a list and the outline of parcels to a Farming Company and retrieve yield maps, share your crop rotation with the agricultural advisor of your Chamber of Agriculture or your Cooperative, give access to your changes in farming practices to your Low Carbon Project Sponsor.

Thanks to AgriTrust Consent, farmers and the entire agricultural supply chain will finally be able to exchange their data in complete confidence while maintaining control.

Interoperable data between MesParcelles and MyEasyFarm via API-Agro

MyEasyFarm data offers will also be published in the API-Agro catalog, which will allow data exchange with other applications in the catalog, including first and foremost the <u>MesParcelles</u> solution of the Chambres d'agriculture France. This data exchange will of course be controlled by the AgriTrust Consent module.

Initially, farm and parcel data will be available in this exchange. The data flow will be enriched over the course of the year and will allow a farmer using both MesParcelles and MyEasyFarm to transfer the data of his planned and completed interventions and avoid any re-entry between the solutions.

"Collaborating with Agdatahub and using their solutions will allow MyEasyFarm to meet the requirements of the new European regulation on data governance (Data Governance Act) which will come into force in Europe in September 2023. But above all, this partnership will allow our farmers to secure access and control the sharing of their data with other agricultural actors", says Francois Thierart, CEO of MyEasyFarm.

"The trusted third party data intermediation platform proposed by Agdatahub makes sense when implemented in a way that respects the data and its rightful owners. It is to develop trust by promoting the return of value to agricultural producers through digital solutions that we work daily. The ecosystem set up within this framework clearly shows the need to organize data access for the agricultural sector", emphasizes Sébastien Picardat, Managing Director of Agdatahub.
